TOOTHPICKS - The round, stronger toothpicks have a multitude of uses on the jewelry bench. I use them for mixing epoxy resin, for applying paste solder, with Zam for polishing in tight spots, and with a bit of beeswax for picking up and positioning small stones. They're particularly good for test-

ing the fit of a small faceted stone in a prong or tube set finding.

PUMICE WHEELS - Pumice wheels are good for touching up a bezel after you've set the stone. The hardness is about 6 on the Moh's scale, less hard than quartz, so it shouldn't scratch any of your jaspers. However, I'd avoid or be real careful of using pumice near the softer stones like turquoise, amber, howlite, etc. If you're unsure that a wheel is pumice, test it with a piece of glass. Glass is about 5 ½ on the Moh"s scale. If it doesn't scratch glass, it shouldn't scratch quartz.

Staurolites



Staurolite is a metamorphic mineral that is famous for its twinned crystals that form the shape of a cross. It is composed of iron aluminum silicate and its color ranges from yellowish brown to reddish brown to black. It can be transparent or opaque. It forms with garnet, tourmaline and kyanite in mica schists and gneisses and other aluminum-rich metamorphic rocks. They can be found in Virginia, North Carolina, Georgia and New Mexico. Deposits are also located in Russia, France and Brazil. It is the official state mineral of Georgia The cross most commonly forms at a 60 degree angle (St Andrew's Crosses) but the 90 degree angle (Greek Crosses) is most sought after. They sometimes form with

both types of crystals creating a specimen that looks like a 6 rayed star. Staurolite gets its name from stauros, the Greek word for cross but is also known as Fairy Stone and Fairy Cross. It has long been prized as a good luck charm and is thought to aid in healing and provide protection from evil spirits. A popular Christian legend states that tears shed by the angels at the time of Christ's crucifixion crystallized and fell to the earth as Staurolites. Other legends claim they were formed by the tears of fairies, shed in sorrow over the death of Christ. The Cherokee have their own legend which tells of the little people who brought to them a tale of greatness and sadness. The little people spoke of a special boy-child who had grown into a man of wisdom and taught his people the ways of the Creator and the straight white path of peace. He brought strong medicine (nuwati) to his people but had many enemies who would not hear his message of peace. On this day they would torture and kill the wise man. Because of their sorrow, the Cherokee began to cry. When their weeping had ended they looked down and saw that their tears had been changed into small stone crosses. (legend preserved by the Chiltoskey family of Cherokee North Carolina) The Cherokee also tell of an annual ceremony centered around staurolites that was held at the Spring Solstice full moon. At sunset staurolite crosses would be put into the fire and heated until they were glowing hot, then carried to a special mound with green sticks. There they glowed for hours and were reheated as necessary to keep them hot until sunrise. The ceremony assured the people of safe passage, rain during the growing season and an abundance of food in the fall. Sources: ·

The Remarkable Eye of a Trilobite

The eyes of trilobites, small extinct arthropods of the Paleozoic Era, have been found to possess sophisticated, glass-like lenses capable of producing clear images over a wide depth of field. The lenses owe their remarkable properties to their impregnation with the mineral calcite, specifically calcite with its crystal structure arranged precisely to produce the optical properties of glass, says Kenneth Towe of the paleobiology department of the Smithsonian Institution. The crystal orientation is so accurate and consistent from specimen to specimen that it must have been due to a process of bio-mineralization. The "calcite lenses," says Towe, "must have been present during the life of the animal." To study the optics of the lenses, Towe embedded

specimens in clear epoxy, face down on glass slides and looked at objects through the eye with a microscope. The result was inverted images that stayed in focus from a few millimeters to optical infinity. A few living arthropods have calcified lenses in their eyes, but their poor crystal orientation would produce double vision.

Cheesy Potato Corn Chowder with Bacon

This is a big recipe. You may cut it in half. My favorite for a cold day!

l onion diced 5 stalks celery diced 2 tablespoons light oil **Put oil in 2 gallon pot add onions and celery and brown lightly.** Add: 3 cans chicken broth. I use the fat free low sodium one. 10-12 potatoes peeled and cubed Salt & pepper 1 tablespoon dried parsley flakes

If the liquid does not just cover the potatoes add water till it does. Bring up to boil and cook till potatoes are done. With a potato masher smash potatoes till about $\frac{1}{2}$ of them are smashed. Stir.

Add: 1 cube butter or margarine

2 cans corn drained. If you want more color add the Mexicorn as it has both white and yellow

corn and a few red peppers in it. Looks great!

16 oz cheddar cheese shredded or 8 oz. Velveeta cheese

1 can canned milk. I use the fat free one.

Cooked bacon. I use 2 packages of the pre cooked cut into $\frac{1}{2}$ in pieces. You may use fresh cooked bacon or real bacon bits. You need 2 cups.

Bring up to boil while stirring. Eat up!

San Gabriel National Park. Is it in YOUR Future?

More than 700,000 acres of the San Gabriel Mountains, River and Valley and Puente Hills were deemed nationally significant and therefore suitable for inclusion in the National Park system, according to a report released Monday by the U.S. Department of Interior. The Draft San Gabriel Watershed and Mountains Special Resource Study concluded that the mountains and the Puente Hills met the criteria for a national designation and that all or portions could come under federal protection and management if approved by Congress. <u>http://parkplanning.nps.gov/document.cfm?documentID=43639</u>

The draft stops short of recommending a traditional national park. Instead, it offers four strategies: (1) do nothing, (2) merge the San Gabriels into the Angeles National Forest, (3) turn the San Gabriel River watershed into a National Recreation Area, or (4) create a partnership for the region with several agencies.

Please think for a minute. There is NO rock collecting in any National Park. Rules are still being made for a National Recreation Area. The reason we need people at attend these meetings is so we have a voice regarding these changes.

If it becomes a National Park, there goes collecting Actinolite in Pine Canyon Wash, Rhodonite near Wrightwood, Garnets along the Angeles Forest Hwy, GOLD Prospecting and free road trips over the Angeles Forest Hwy and between the Antelope Valley and Pasadena and trips to Mt. Wilson. The BIG PARK is coming through...... <u>http://www.landrights.org/VideoBigPark.htm</u> We need a strong community turnout at these meetings to help convince the Park Service that if a recreation area is created, the needs of the Rockhound Community must be considered in the planning process.

BAKERSFIELD FIELD OFFICE, CALIFORNIA: MINES AND MINERALS IN AREAS OF CRITICAL ENVIRON-MENTAL CONCERN AND SPECIAL MANAGMENT AREAS

There is another problem area. The BLM Bakersfield Field Office has a new Land Use Plan. This covers Kern, San Luis Obispo, Santa Barbara, Madera, Fresno Counties. I would affect Horse Canyon (agate, gemstones) as well as many gold, feldspar and scheelite collecting. Again we need to make our voices heard. If we do not, things will happen without our input. (we have a listing of specific mines and areas that would be affected, if interested a copy will be e-mailed--it is too long for the bulletin).

We are being asked to send a letter asking the BLM the following questions?

BAKERSFIELD FIELD OFFICE LAND USE PLAN QUESTIONS TO ASK BLM

1. Where will mineral collecting and mineral exploration/development will be prohibited or restricted? Please provide a map.

2. What are the known mineral collecting sites or mines in the Decision area? Please provide a map. Include location information (county, township, range, section, latitude, longitude, name of site)

3. What mineral collecting sites or mines will be removed from casual use, exploration or development? Please provide a map and a list of sites.

4. For mineral collecting sites or mines that are not closed to exploration or development, how will access be restricted or allowed to them?

5. For areas proposed for closure, why was closure chosen? What other alternatives to closure were considered? Was restricted access by permit considered as an alternative to total closure? Under what conditions can vehicles be used to access the site? Please provide a list of sites and summary of access restrictions to each one.

6. How did BLM calculate economic impacts of mineral collecting and mineral exploration and development?

7. Did BLM consider that mineral collectors contribute to local economies by their exploration activities?
