Fellowship was asked it there were any, previously recognized, members that were disabled or sick. **Michele** announced that **William Preston Bowling** representing the Friends of LA River will speak on interests and education in the earth sciences including geology, mineralogy, paleontology and the Arts of Lapidary. would be next month's speaker. The club picnic, scheduled for Sunday July 12th, 2015, 11:00 AM to 3:00 PM Memorial Park Pavilion, 222 W. Sierra Madre Blvd. Sierra Madre, CA, was announced with food sign-ups explained and made available. Having announced the board's choice for Auditor in the bulletin, **Kevin P. Doran** was elected by unanimous vote. Reminders were made for membership dues as non-payers are now delinquent. Janie announced the schools and presentations she would be making during the coming month. The Webers then announced they were able to start their lecture. We learned many new things about the Pilbara Region and also about Australia in general. The concept of multi-trailer

trucks as effective "trains" was completely new. One tractor and up to 17 trailers behind. The area they were collecting in is about the same size as California. We learned about Stromatalites <u>http://tinyurl.com/cgw2fuc</u> that converted our water world 3.5 Billion years ago into one with a breathable atmosphere 2 Billion years later. In the process those varieties of plant life deposited iron as some of the oldest rocks known. in forms, colors and shapes that we all crave as rockhounds. Miners and rock collectors use large baskets to store multiple tons of rocks each that are moved about on these truck-trains. They always have the right-away. Other casual words of advice they gave: always carry your back-hoe with you if you are going rock collecting and only try to collect in the dry season. Most roads were not paved and rivers often do not have bridges.

They brought a large assortment of rocks they had collected. We got two samples of rock from them that will be put up at our rock drawing and they will be coming back to give another lecture, tentatively in November, about the rocks from the Rain Forest portions of Australia. *Per Cal Matthews, President*

Over the past ten years, Mr. Bowling has been working at FoLAR on various projects including his brainchild, now in it¹s second year, a catch & release fishing derby, "Off tha' Hook" With a vast knowledge of Los Angeles River History, Bowling hosts several tours of the Los Angeles River including quarterly photography tours. Currently Mr. Bowling is in the 4th phase of a Los Angeles River fish study as Project Manager, looking at the toxicity of fish residing in the lower watershed at Long Beach.

May 28th 2015

Monrovia Rockhounds Board Meeting Location: Monrovia United Methodist Church

Note: This location was chosen after substantial searches for an inexpensive meeting place in several cities. Days and times were made flexible without getting a suitable free or low cost place. The church was chosen as the least expensive and private spot after an earlier location had been chosen then found to be inadequate.

Meeting was called to order at 7:35 PM. Welcome was offered to representatives, non-officer chairs and other club members. Officers present were Cal Matthews, Michele Silcock, Jim Lloyd and Kevin Doran.

Denise Davis, Secretary, was absent. Chairs present were Jo Anna Ritchey and Janie Duncan.

Representatives included Colleen Chestnut and Ray Ritchey. Please forgive and provide corrections to these meeting minutes as Cal Matthews tried to take notes while conducting the meeting.

Approval of prior month's board minutes was deferred until the Secretary can present them.

UNFINISHED BUSINESS

Fiscal year income and expenses were approved unanimously by the board after explanation of several items including the income by non-cashed check. Proposed presidential budget was also approved with modification of show publication expense increase and will be presented to membership at the next general meeting. Show income and expenses were approved after stating that the numbers were cash numbers without carry-forwards of deposits from previous year's and for the next year's shows. These are all based on Treasurer's check register and receipt book.

CHAIR REPORTS

Treasurer: Report of our bank balance was given and the number of paid members announced. One new member, RoxAnn Sanchez, completed her application and paid her dues.

Membership: Chair not present, Transportation crisis of car breakdown.

Fellowship: Chair not present, moving away to Northern California, replacement needed.

Custodian: No issues.

Show: All task description have been completed. Budget has been submitted.

Federation: Reservations have been made and funds authorized.

Education: This is a new position. Janie currently plans to enable this function. Her schedule will include three presentations to school classes and two classes for groups of BSA.

Field Trip: We have a new person as Chair. Kevin Doran presented information on the "combined lapidary clubs" field trip to the Pala Tourmaline mine in San Diego county on the 20th of June. This is a fee dig location and our price will be \$50 for a 10AM to 3PM tailings search. You get to keep what you find.

Bulletin: After Janie Duncan's resignation Denise Davis volunteered to publish our material for both hard copy, email and web publication (through Jo Anna Ritchey).

NEW BUSINESS

Details of the club picnic were repeated (Sierra Madre Memorial Park Pavilion, Sunday, July 12, 11:00AM start).

Next month's speaker details were given (William Preston Bowling representing the Friends of LA River will speak on interests and education in the earth sciences)

Requests from club representatives concerning the May 21st general meeting were addressed next.

From Representative Colleen Chestnut:

1) "Will there be a photographer anymore?" After discussion with board and members it was decided to ask at least three people to take casual pictures of the meeting, our speakers and our members so we can get better coverage and variety for our Bulletin. (The pictures will be sent to our editor for selection.)

2) "What is the decision on dues?" is primarily a complaint about using a direct vote to change the dues rather than going through the approval of a bylaw change to raise them. It was agreed that many changes need to be made to make the bylaws more flexible and up to date with our operational needs.

It was agreed that the present Bylaws require a change to alter our payment amount and it was incorrect to proceed to make the change by motion at a general meeting. The amount of our dues still need to be increased because of increased costs to the club. A further problem is: do we revoke the increase now, change the Bylaws then reinstate the increase? It was requested that the Bylaws have the amount of dues be removed from them. The board will bring to the June general meeting the revocation (or not) of dues increase, how best to control the dues amounts, appointment of a committee to change the Bylaws for this and other needed changes.

3) "Will there be an agenda at the meetings?" There was and there will be in the future. Further clarification of the request indicated that members wanted to look at the agenda. It was suggested that a copy be at the check in table. One suggested alternate was to use the club projector to display items on a nearby wall. Measures are being taken to do both of these ideas.

4) "Want to see the Treasury Report" The board agrees completely. There has not been one for more than five years was mentioned. It is to be presented at the June meeting. It will be based on Treasurer's check register and receipt book.

5) "Want an apology for calling the police at the meeting" It seems that the people that were causing the disturbance and not permitting our Vice President to close the meeting feel that we should apologize for not letting the verbal mayhem that was escalating continue. The president asked the Secretary to call the police since the meeting had become so heated and could no longer be controlled.

6) "Want to hear the reports by all the chairs and representatives" The reason the reports have been shortened was due to complaints of not having enough time for our speakers. The reports are important and will continue to be presented when there is new information to be presented.

A new form of advertising for the show was suggested - yard signs at member homes.

Mineral Information The Tourmaline Group of Minerals

The tourmaline group of minerals, like the mica group of minerals, are silicate minerals that have complicated chemical formulas. The chemical formula for the colorful variety of tour-maline (elbaite) is NAI, Fe, Li, Mg)3B3AI3(AI3Si6O27) (O, OH, F)4. Compare the chemical formu-las in the chart below. You can see that they all share AI3Si6O27 and (OH)4 in their formulas. They are hard and have glassy luster. They all crystallize in the hexagonal crystal system. They commonly form long, prismatic crystals, but they can also form short, fat crystals. Multi-colored crystals are commonly found. The varieties of tourmaline in the tourmaline group are schorl (black), dravite (garnet-red to brown), uvite (white), colorless (achroite), and elbaite (red, green, blue, yellow and combinations of these colors). The colorful gem varieties of elbaite have their own special names. Red tourmaline is called rubellite, green is called verdelite and blue is called indicolite. When you study the long, thin tourmaline crystals you will see straight lines the run up and down on the crystal. This part of the crystal is called the prism by mineralogists. The long, straight lines are called striations.
