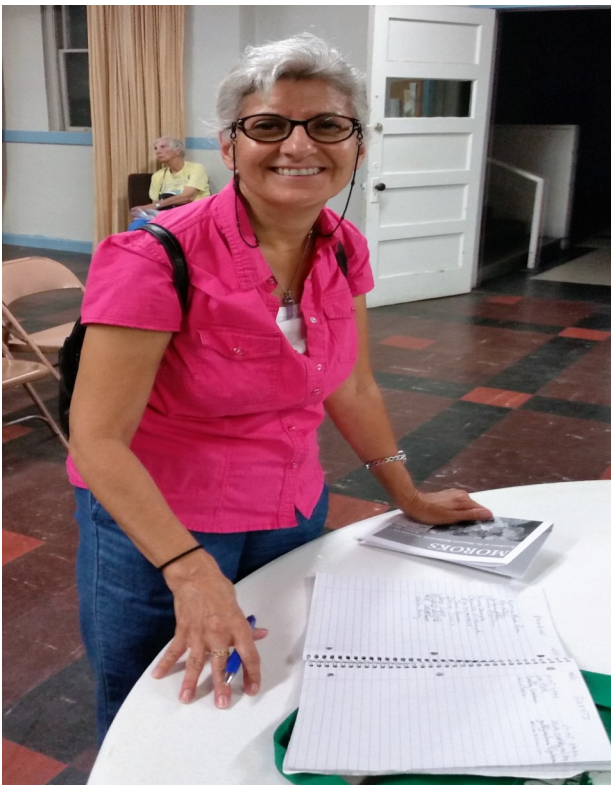

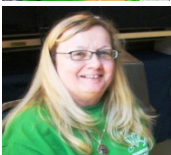

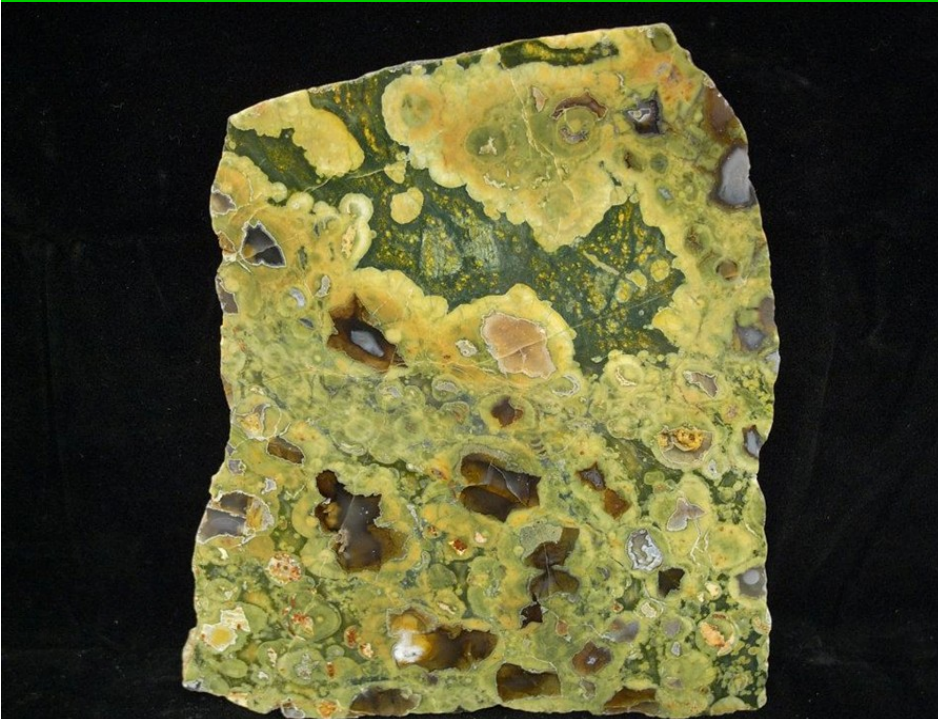

This beautiful green rhyolite has a distinctive look making it a favorite of mineral collectors and lapidary enthusiasts for the past 50 years. Along with the Mt. Hay thundereggs, this unique material is only found in one location in the world.

Mary Pat & Dick are retired geologists. While touring Australia they formed a friendship with the family that discovered and currently operates the Rainforest Jasper mine. They were granted access to restricted areas of the mine and able to examine the private collection of the owners. The Weber's will bring display specimens from their own personal collection for viewing.

## Monrovia Rockhounds

### Education Report

The Monrovia Rockhounds offers free presentations to elementary students and home school groups throughout the Los Angeles area. Our goal is to provide an informative and educational program that will encourage youth to develop an interest in rock hunting and the lapidary arts. Janie Duncan, Education Chairman offers 2 talks.

The Dinosaur Talk is geared for Kindergarten through 3rd grade and is about 25 minutes long. She teaches how fossils are created, types of dinosaurs and brings real fossils and her hadrosaurus dinosaur egg to the classroom. Each child receives a free tumbled stone to take home.

"Rock Talk" is for 4th grade and up. This talk is also offered to other groups such as Senior Citizens. The program is about 1 hour long and teaches the 3 types of rocks, local LA area Geology, Mohs Hardness scale, Crystal structure, erosion, meteorites, fossils and dinosaurs. The talk is hands on and the specimens are generally passed around for tactile learning. Each person gets a free tumbled stone and Monrovia Rockhounds Show flyers.

Janie Duncan also offers free tours of the "Good Old Days Museum" at her home in Monrovia by appointment only. See thousands of rocks, fossils and minerals and much more. Groups are welcome.

The Monrovia Rockhounds will help teachers upon request with building up a classroom rock collection or supply egg carton collections for a nominal fee.

Janie Duncan is also a Cub Scout Geology expert and has helped over 5,000 scout earn their activity pins as well as other cub level requirements. Janie also works with Girl Scouts of various ages meeting requirements in both rocks, geology, collecting and beading. All Scout programs must be scheduled and are free of charge.

If the Monrovia Rockhounds meetings has regular attending juniors a monthly education program and or rock craft class will be offered.

## OCTOBER 2015 MONROVIA ROCKHOUNDS BOARD MEETING

Meeting Called to Order at 7:06 PM

Present: Board of Directors: Cal Matthews – President, Denise Davis – Secretary, Jim Lloyd – Treasurer. Auditor - Kevin Doran. Not present: Michele Silcock - Vice President.

Chairs: Custodian-Jim Lloyd, Newsletter/Membership- Denise Davis, Field Trips-Kevin Doran, Show/Webmaster-Jo Anna Ritchey. Not Present: Fellowship- Linda Doran, Education-Janie Duncan, Programs/Bylaws-Michele Silcock

Representatives & Members: Representative-Ray Ritchey. Members Present: none.

A Teleconference was attempted to include Michele in the meeting but the connection was too poor.

Minutes corrected from last month's minutes to read October for the next Board meeting.-Ray Ritchey.

### **Unfinished Business:**

JoAnna started the meeting with her issues. She requested the Board to clarify their determination that the March 2016 Show would not have any free or heavily discounted booths for anyone. The matter was discussed and the Board instructed Jo Anna to send letters to anyone involved in this matter that they would not get a free or almost free booth.

Jo Anna brought up issue of the Fiscal year change and forewarned the Board she would voice her objections at the General Membership meeting.

Jo Anna complained that Michele did not call another meeting of the Bylaws Committee when she was asked to. Michele was not present to issue a counter-statement but Denise & Kevin stated they knew nothing about a second meeting about Bylaw changes.

Denise requested that the Agenda be followed.

Treasurer's Report: Jim busy paying some bills, no final amount provided. Said total checks written were for garage rent, meeting space and Nancy Bird fee for September Program. (Gas money only.) Paid Members: 33. Income was stated as \$924 from Vendors for the 2016 Show. Denise noted that quarterly audits have not been done.

Membership: No new members, 1 resigned. (William Davis.) Visitors at last Meeting: 5. Members at Meeting: 13. The resignation was discussed.

Custodian: Jim said the garage rent is going up to \$200/month from \$150. The Board requested Kevin to get some comparison rates from Public Storage etc. Jim suggested not moving the garage items until the 2016 Show. Shelving for storage was discussed if a move was made. No actions taken. Jim is to measure current space & get info to Kevin.

MAFA Show: Income was \$513.

March 2016 Show: Jo Anna presented bill for \$300 for Arboretum sponsorship. This is required to use the facility. Jo Anna mentioned use of her tax ID number related to Club Business for MAFA/Show and resale license. Cal approved payment to Arboretum. Denise again requested that Arboretum memberships that comes with this sponsorship is offered to the membership at a General meeting.

Education: No Info. Chair Janie Duncan declines to attend Board meeting in Pasadena.

Field Trips: Kevin was requested to plan Field Trips that is appropriate for the current group of members, such as UCLA meteorite display, museums, etc. It was requested that Kevin supply the Field Trip schedule in the newsletter 3 months in advance.

Newsletter: Eleven (11) copies were mailed at a cost of \$7.50 and Nancy Hamrick donated \$5.39 in postage.

Webmaster: Jo Anna was requested again to update the Website to the current Board, the annual show page to 2016, the Field Trip wording, the member application and renewal forms.

Representative Input: Good speaker for September, no issues per Ray Ritchey.

Discussion of effect of Fiscal year change on budget and Cal felt there would be no effect.

Inventory-still needs to be scheduled and completed. It was said that the auditor needs to be involved in the inventory of the garage.

Treasury: The Board recommends that there be dual signatures by Board members on all outgoing checks as a safeguard to our account. All monies are held in 1 account. Currently Jim Lloyd, Janie Duncan, & Jo Anna Ritchey are on the bank account as signers. There is a 4th person but they say they cannot remember who it is.

**New Business:** Tabled until November.

Motion to adjourn by Denise Davis, second by Cal. Time of Adjournment: 8:26 PM.

## MEMBERSHIP NEWS AND DUES

One result of the Fiscal year change for Monrovia Rockhounds is the date the annual dues are due. Previously members were paying dues anytime from November thru July, and there was much confusion regarding exactly what year they were paying dues for. Now annual dues are due January first of every year. Collection of annual dues should begin October of the previous year so that all monies are collected by January 1st of the new year and an accurate count can be given to CFMS when the Club submits the annual insurance payment.

For Fiscal Year 2016, January 1st through December 31st 2016 dues are due NOW and payable to Treasurer Jim Lloyd. If you submit your dues by mail use the Club address, PO BOX 553, Monrovia CA 91016-0553. A renewal form is requested of all members and is attached with this newsletter as well as being available on the website for you to print at home.

However for those of us who paid a full year's dues in April for 2015, the 2016 dues will be prorated with a credit for one quarter of the year. The balance will still be due January first 2016.

Schedule of dues: 2015 paid individual members will pay \$15 for all of 2016. You must pay by January 1, 2016 to get this rate. (\$5 credit from 2015.)

Additional members in the same house hold who were members in 2015 will pay \$7.50 for all of 2016. You must pay by January 1, 2016 to get this rate. (\$2.50 credit for 2015.)

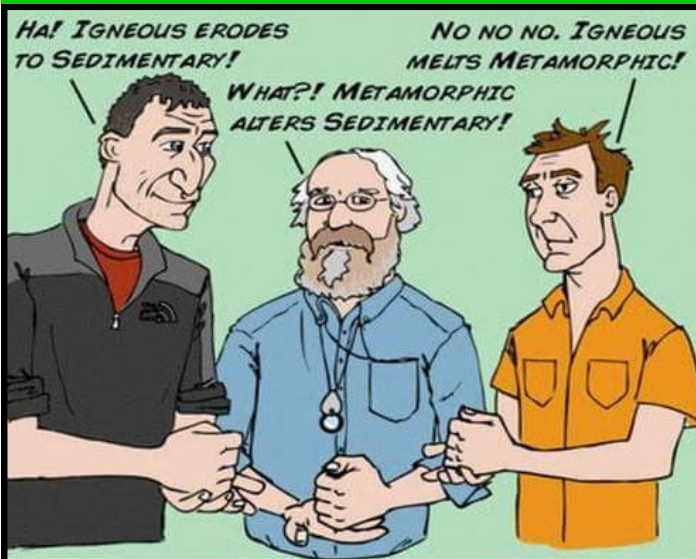
So for 2 people at the same address who were paid members in 2015, the dues will be \$22.50 for 2016.

Those wishing to join for 2016 but were not paid members in 2015 will pay full dues of \$20 for individual membership and \$10 for each additional member at the same address. There is also an initiation fee of \$10 per person to be paid at the time the membership application is presented to the Board. No applications will be accepted without review by the Board. The full application form needs to be completed. The Club will not accept partial payments for dues.

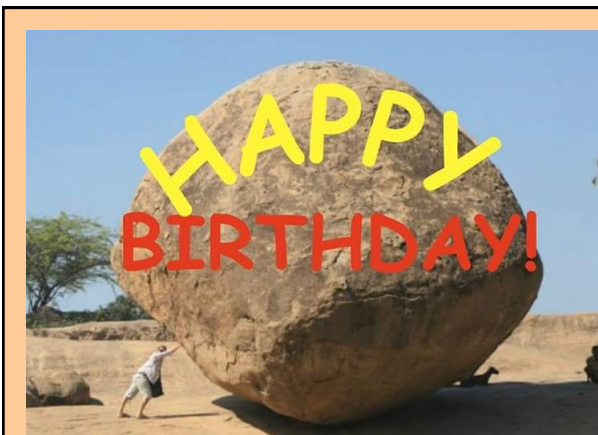
