SMALL PARTS CONTAINERS I'm always on the lookout for small containers to use for holding those various little parts and tools we deal with in making jewelry, especially since I go back and forth to classes and workshops. My latest find are some plastic vials about 15 mm in diameter and 75 mm long. Best part is they are free. The vials are used in hospitals and doctor's offices to draw bloodsamples. They must be thrown out after their expiration date. On my last doctors visit, I asked the nurse if they had any expired vials. She tried to give me 400 of them. The ones I have are called "Vacutainers", but there are probably other brand

names. They are sterile and made of clear plastic with a rubber stopper and a paper label all ready to write on. I find them really handy for small parts like jump rings, prong settings, small drills, nuts & bolts, faceted stones, and precious metal filings. Some other handy containers - pill bottles, 35mm film cans, and metal breath mint boxes.

16 U.S. Code § 3 - Rules and regulations of national parks, reservations, and monuments; timber; leases http://www.law.cornell.edu/uscode/text/16/3

- § 2.1 Preservation of natural, cultural and archeological resources.
- (a) Except as otherwise provided in this chapter, the following is prohibited:
- (1) Possessing, destroying, injuring, defacing, removing, digging, or disturbing from its natural state:
- (i) Living or dead wildlife or fish, or the parts or products thereof, such as antlers or nests.
- (ii) Plants or the parts or products thereof.
- (iii) Nonfossilized and fossilized paleontological specimens, cultural or archeological resources, or the parts thereof.
- (iv) A mineral resource or cave formation or the parts thereof.
- (2) Introducing wildlife, fish or plants, including their reproductive bodies, into a park area ecosystem.
- (3) Tossing, throwing or rolling rocks or other items inside caves or caverns, into valleys, canyons, or caverns, down hillsides or mountainsides, or into thermal features.
- (4) Using or possessing wood gathered from within the park area: Provided, however, That the superintendent may designate areas where dead wood on the ground may be collected for use as fuel for campfires within the park area.
- (5) Walking on, climbing, entering, ascending, descending, or traversing an archeological or cultural resource, monument, or statue, except in designated areas and under conditions established by the superintendent.
- (6) Possessing, destroying, injuring, defacing, removing, digging, or disturbing a structure or its furnishing or fixtures, or other cultural or archeological resources.
- (7) Possessing or using a mineral or metal detector, magnetometer, side scan sonar, other metal detecting device, or subbottom profiler.

This paragraph does not apply to:

- (i) A device broken down and stored or packed to prevent its use while in park areas.
- (ii) Electronic equipment used primarily for the navigation and safe operation of boats and aircraft.
- (iii) Mineral or metal detectors, magnetometers, or subbottom profilers used for authorized scientific, mining, or administrative activities.
- (b) The superintendent may restrict hiking or pedestrian use to a designated trail or walkway system pursuant to
- §§ 1.5 and 1.7. Leaving a trail or walkway to shortcut between portions of the same trail or walkway, or to shortcut to an adjacent trail or walkway in violation of designated restrictions is prohibited.
- (c)(1) The superintendent may designate certain fruits, berries, nuts, or unoccupied seashells which may be gathered by hand for personal use or consumption upon a written determination that the gathering or consumption will not adversely affect park wildlife, the reproductive potential of a plant species, or otherwise adversely affect park resources.
- (2) The superintendent may:
- (i) Limit the size and quantity of the natural products that may be gathered or possessed for this purpose; or (ii) Limit the location where natural products may be gathered; or (iii) Restrict the possession and consumption of natural products to the park area. (3) The following are prohibited: (i) Gathering or possessing undesignated natural products.
- (ii) Gathering or possessing natural products in violation of the size or quantity limits designated by the superintendent.
- (iii) Unauthorized removal of natural products from the park area.
- (iv) Gathering natural products outside of designated areas.
- (v) Sale or commercial use of natural products.
- (d) This section shall not be construed as authorizing the taking, use or possession of fish, wildlife or plants for ceremonial or religious purposes, except where specifically authorized by Federal statutory law, treaty rights, or in accordance with § 2.2 or § 2.3.

Note: Regulations concerning archeological resources are found in 43 CFR part 3.

- § 2.5 Research specimens.
- (a) Taking plants, fish, wildlife, rocks or minerals except in accordance with other regulations of this chapter or pursuant to the terms and conditions of a specimen collection permit, is prohibited.
- (ii) Gathering or possessing natural products in violation of the size or quantity limits designated by the superintendent.
- (iii) Unauthorized removal of natural products from the park area.
- (iv) Gathering natural products outside of designated areas.
- (v) Sale or commercial use of natural products.
- (d) This section shall not be construed as authorizing the taking, use or possession of fish, wildlife or plants for ceremonial or religious purposes, except where specifically authorized by Federal statutory law, treaty rights, or in accordance with § 2.2 or

§ 2.3.

Note: Regulations concerning archeological resources are found in 43 CFR part 3.

- § 2.5 Research specimens.
- (a) Taking plants, fish, wildlife, rocks or minerals except in accordance with other regulations of this chapter or pursuant to the terms and conditions of a specimen collection permit, is prohibited.
- (b) A specimen collection permit may be issued only to an official representative of a reputable scientific or educational institution or a State or Federal agency for the purpose of research, baseline inventories, monitoring, impact analysis, group study, or museum display when the superintendent determines that the collection is necessary to the stated scientific or re-
- source management goals of the institution or agency and that all applicable Federal and State permits have been acquired, and that the intended use of the specimens and their final disposal is in accordance with applicable law and Federal administrative policies. A permit shall not be issued if removal of the specimen would result in damage to other natural or cultural resources, affect adversely environmental or scenic values, or if the specimen is readily available outside of the park area.
- (c) A permit to take an endangered or threatened species listed pursuant to the Endangered Species Act, or similarly identified by the States, shall not be issued unless the species cannot be obtained outside of the park area and the primary purpose of the collection is to enhance the protection or management of the species.
- (d) In park areas where the enabling legislation authorizes the killing of wildlife, a permit which authorizes the killing of plants, fish or wildlife may be issued only when the superintendent approves a written research proposal and determines that the collection will benefit science or has the potential for improving the management and protection of park resources.
- (e) In park areas where enabling legislation does not expressly prohibit the killing of wildlife, a permit authorizing the killing of plants, fish or wildlife may be issued only when the superintendent approves a written research proposal and determines that the collection will not result in the derogation of the values or purposes for which the park area was established and has the potential for conserving and perpetuating the species subject to collection.
- (f) In park areas where the enabling legislation prohibits the killing of wildlife, issuance of a collecting permit for wildlife or fish or plants, is prohibited.
- (g) Specimen collection permits shall contain the following conditions:
- (1) Specimens placed in displays or collections will bear official National Park Service museum labels and their catalog numbers will be registered in the National Park Service National Catalog.
- (2) Specimens and data derived from consumed specimens will be made available to the public and reports and publications resulting from a research specimen collection permit shall be filed with the superintendent.
- (h) Violation of the terms and conditions of a permit issued in accordance with this section is prohibited and may result in the suspension or revocation of the permit.

Note: The Secretary's regulations on the preservation, use, and management of fish and wildlife are found in 43 CFR part 24. Regulations concerning archeological resources are found in 43 CFR part 3.

Henry the IIIV Crown Colin Lansdell via Stone chat

Until recently, the only way you could tell what Henry VIII's crown looked like was to go to see his 1631 portrait at the National Portrait Gallery. The painting shows a bare-headed Henry with the crown, in all its detail, beside him on a velvet-draped table. The crown was used on very rare occasions during his reign but was used for the coronations of his children Edward, Mary and Elizabeth, and then of James 1 and Charles 1. After Charles was beheaded the crown was broken up and the gold sent to the mint for coinage. The gems and pearls were bagged up and sold off in mixed lots like sweets. Only one item of royal regalia escaped the



melting pot, a 12th century spoon. Now, under the direction of Harry Collins the former crown jeweler who retired last year, a host of expert craftsmen have recreated the crown. It involved hundreds of hours for the workers, using Tudor techniques, to replicate the masterpiece. The budget, paid for by sponsors HRP, came to a five-figure sum which has not been disclosed. The original is listed in an inventory at Henry's death has having 344 gems, including "pearls not all of one sort and three Sapphires". What the budget did not run to the three kilos of gold, of the original, and gold-plated silver was substituted, as was rock crystal for the huge diamond. The new gems were sourced from Sri Lanka, in the main. The crown is now exhibited at Hampton Court Palace in the royal pew of the Chapel Royal.





HOW CAN I TELL THE DIFFERENCE BETWEEN QUARTZ & WHITE FELDSPAR IN IDENTIFYING ROCKS? submitted by Terry Fetzer via The Golden Nugget MONTGOMERY GEM AND MINERAL SOCIETY

Feldspar grows into rectangular crystals, and then usually breaks the same way. This breakage pattern is called cleavage, and feldspar has two directions of cleavage that meet at close to a 90 degree angle (just like a stairway). If you see little sparkles when you look at the rock, the flashes may be the light reflecting off the mirror-like cleavage surfaces. Quartz has no cleavage (it breaks with a conchoidal fracture just like obsidian, or the curved fractures that you can often see in the windshield of your car after a rock hits it), so no mirror-like flashes of light. The bad news is that sometimes the curved conchoidal surfaces can flash as well, but this usually hap- pens with the clear varieties of quartz (which you already know isn't feldspar any- way). So, if the mineral has cleavage and sparkles, it may be feldspar. If no sparkles, no matter how you rotate it in the light, it may be quartz. http://mazinggeology.blogspot.com/2014/09/how-can-i-tell-difference- between.html#lfE6qCH3Jje8oV8w.99

Mars Science Laboratory: The Curiosity Rover Years 1&2 By Dr. Sarah Milkovich (JPL) Friday November 14, 2014 7:30pm in the Volsloh Forum at Pasadena City College: The Curiosity rover landed at Gale Crater, Mars, in August 2012, kicking off two years of exploration of the crater floor and a mountain of layered rocks and sediment inside the crater.
